After a successful inaugural year of the PGA of America's Deferred Compensation Plan, which saw more than 5,800 PGA of America Members enroll in the program, we are even more excited for the start of the upcoming plan year and the opportunities it can provide for our Members for years to come. The new plan year runs from April 1st, 2024 - March 31st, 2025 which is the same as the PGA fiscal year.

As most of you know, for many years the PGA of America has searched for a way to develop some kind of retirement plan for its members and now that has finally come to fruition. Our goal for this program is to be able to reasonably compensate members for performing services that advance our exempt purpose; specifically for growing the game of golf.

For this second year, the same 16 activity categories have been approved so that members can participate to earn points towards Deferred Compensation. Each activity will have an assigned point value for completing them and if a member reaches a minimum of 200 points in a plan year, they will be eligible to receive a contribution to their Deferred Compensation Plan from the PGA of America. These activities range from involvement in PGA Jr. League, PGA HOPE, Volunteer, & Philanthropic engagement.

We believe this is an excellent opportunity for our members to accumulate wealth and supplement their income during their retirement years, all while helping grow the game of golf and making it more accessible to everyone. **Test-out Option for Established Reciprocity  
and  
Class A-3 Tour Player Members with 30 Work Experience Credits**

Current or former Class A members, of the Australian, British, Canadian, German, New Zealand and South African PGA's, or

Current and former Class A-3 PGA TOUR Player members, who have accumulated 30 experience credits (which can be a combination of tour participation credits and/or college education credits), have been provided the opportunity to "test-out" of the PGA Professional Golf Management Program (PGA PGM) education requirements in lieu of completing the program in its entirety. The "test-out" option is a battery of knowledge tests, which includes a test on the PGA Constitution and Bylaws.

Upon verification of international PGA membership or PGA TOUR work experience credits, it will then be necessary for an individual to complete the following membership requirements:

- **Complete, scan as a PDF and email the History Sheet to email to [membership@pgahq.com](mailto:membership@pgahq.com) for review and approval.**
- **Complete the battery of knowledge tests for the online Qualifying Level and the 3 levels of the PGA PGM 3.1 Program within two (2) years from the date of purchasing the Level 1 study materials.**
- **Obtain Eligible Employment.** An individual **must** be primarily employed in the area required by the active classification. The definition of primary employment and classifications for Class "A" members may be found in the current PGA Constitution and Bylaws, Article V, or can be viewed on PGA's website: [www.PGA.org](http://www.PGA.org) by clicking on Become A PGA Member icon, then the PGA PGM Program icon, then the link for 'Following Classifications', scroll to bottom of the page, Click Here for all classifications and definitions.
- **Complete a Background Check.** To complete the Background Check, log onto <https://account.pga.org/background-check>. *(If you have been convicted of a felony, misdemeanor or equivalent, you should submit documentation to the PGA Membership Department to determine your eligibility for PGA Membership prior to proceeding. Per the PGA Code of Ethics, certain transgressions are cause for permanent preclusion to PGA Membership.)*
- **Obtain and complete a Member Change Form (current PGA of America member) or Membership Application (International PGA member or former PGA of America member).**

This procedure applies to Class "A" members of the above international PGA's and to current and former PGA of America Class "A3" members who have accumulated 30 work experience credits only.

This procedure is not available for reciprocation of Associate requirements or to those with less than 30 work experience credits. Such individuals will be required to complete the PGA PGM Program in its entirety, excluding the Playing Ability Test (PAT).
